<u>State officer report</u>- Saurabh Mahajan presented the state officer report highlighting accomplishments since the last BOT meeting. These included:

#### Management team report-

- Oregon CTE Student Leadership Foundation money from fed goes to Oregon CTE student leadership foundation, Sherrill is the current Oregon DECA representative, DECA report was well done-worked toward self-sufficiency, October 21<sup>st</sup> must resubmit proposals (we plan to just use previous proposal)
- *Progress made with transition* everything has been moved to storage unit shared with FBLA, finances are not kept track by Brycen Woodley and Ryan Underwood
- Governance and incorporation now board of directors, incorporation sent into state, Trina Lee completed 990

#### State Conference-

- Grievance process for SCDC make sure that process is followed or else grievances won't be considered. Talk about at advisor meeting at SCDC. Grievances that are filed need to be taken care of ASAP.
- Early bird registration -
- Recognition for Trina Lee Bob Reinhardt is taking care of...possible other recognitions for advisors that have left Oregon DECA
- *Professional selling events* keeping on the same date, Dustin Purnell needs help. Getting alumni to come help with events, provide hotel rooms for some, create a code of conduct for alumni helpers
- Online registration costs \$1 per student, possible to edit submissions, this is something Brycen Woodley and Kevin are looking at.

<u>4 The movement</u> - National MDA fundraiser, eventually raise 1,000,000 in a school year. This year increase by 100,000. Get 8 Oregon DECA chapters to raise 500 dollars march 30<sup>th</sup> 2012. Have state officers help chapters reach this goal and check in with chapters who agree to participate. A toolkit to enforce this will be provided by national DECA. Agreed that this will be launched in Oregon, officers will launch it.
